

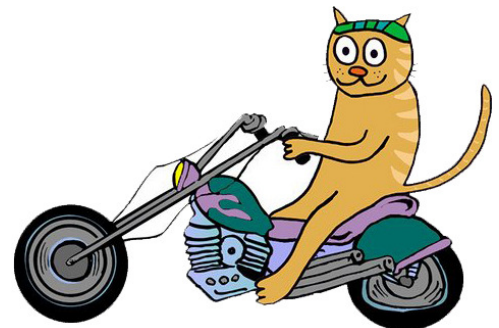

**Show Hall:** Ocean Center Convention Center 101 N. Atlantic Ave. Daytona Beach, FL 32118. Ph: 321-254-4500. The show hall is air-conditioned and is handicapped accessible. Food will be available. **NO OUTSIDE FOOD IS ALLOWED.** Parking is \$10/day; each exhibitor will receive a pre-paid parking voucher for one car each day with their entry confirmation.

**ADA:** Any needed accommodations must be requested 30 days in advance.

**Payment & Entry Info:** Entries accepted now. Entry fees include CFA surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. We are NOT taking PayPal, you can send US bank checks payable to Cat Club of the Palm Beaches to our Entry Clerk or send a payment through Zelle to [catclubofpalmbeaches@icloud.com](mailto:catclubofpalmbeaches@icloud.com) **Check your confirmation for accuracy and contact the entry clerk with corrections BEFORE THE CLOSING DATE.** No substitutions after the closing date. **NO REFUNDS AFTER YOUR ENTRY HAS BEEN CONFIRMED OR FOR FAILURE TO ATTEND THE SHOW.**

\* **OCP Rings Info:** If the number of OCP entrants is not met, there will be no OCP judging. 30 Champions/Opens and 15 Premiers/Opens are required.

**Check-in:** 7 – 8 am, cats not benched by end of check-in will be marked absent and the exhibitor must notify the clerk in each ring that the cat is present. **OCP Judging will begin** at 8:30 am on Saturday. **All other Judging will begin** 9 am on Saturday and Sunday.

**Advertised Show Hours:** 8:30 am – 4:30 pm on Saturday; 9 am – 4:30 pm on Sunday.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

**Household Pets:** All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of all entries must be clipped prior to benching. Declawed cats are not eligible for competition.

**Benching:** Single cage size is approximately 22" x 22" x 22" (and is included with each entry). No more than two kittens or one cat may be benched in a single cage whether entered for exhibition or competition or benched for sale. **Exhibitors with an odd number of entries using any size security cage are required to purchase an extra 1/2 cage.** Please bring cage curtains and grooming aids. Litter will be provided; bring your own litter box, dishes and cat food. Kittens under 4 months old are not allowed in the show hall. Exhibitors must transport cats in/out of the show hall in an enclosed, secure carrier.

**Hotel Info:** List will be sent with your confirmation.

**Airport Info:** Daytona Beach Intl Airport (DAB) is 5 miles/15 minutes from the show hall. Orlando International (MCO) - 76 miles/90 minutes from the show hall.
