## SHOW INFORMATION



**Entry Info:** Entries are accepted now. Entry Fees include CFA & Regional surcharges. HHP, Misc, Provisional & AOV can not be used as 1st entry if pedigree cats are also being entered. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All online entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to New Vision Cat Club, Inc.. Return check fee \$50 + all bank fees. Online payments can be made BEFORE CLOSING DATE via ZELLE to [newvisioncatclub@gmail.com](mailto:newvisioncatclub@gmail.com). Please email entry clerk to confirm online entries. Check your confirmation for accuracy! Please contact the entry clerk with any corrections BEFORE CLOSING DATE. No substitutions after the closing date. No refunds after the entry clerk has confirmed your entry or for failure to bench.

**Check-in:** 7:30 am -8:30 am both days. Any cat not benched by 8:30 am will be marked absent. Please report any transfers or absentees at check-in

**Show Hours:** 9:00 am—5:00 pm on Saturday and Sunday (or until completion of finals). Advertised show hours are 9:00 am – 4:00 pm for both days.

**Show Hall:** TECO Expo Hall; 2310 W Oak Avenue, Plant City, FL 33563. Ph: (813) 754-1126. The show hall is air-conditioned and handicapped accessible. People food will be available. Parking is free (across the street).

**Show Hotels:** Townplace Suites by Marriott Plant City 32709 Thonotosassa Rd. Plant City, FL 33563. (813) 704-5585. Studio, 1 King, Sofa bed - \$159 per night; Studio, 2 Queen - \$179 per night; Hampton Inn and Suites Plant City. 2702 Thonotosassa Rd. Plant City, FL 33563. (813) 756-5600. \$179 for a King or two Queen beds. \$75 pet fee for both hotels. Cutoff date is March 26, 2025 at 11.59pm. We have limited rooms blocked for both hotels so book early.

**Household Pets:** All Household Pets over the age of 8 (eight) months must be neutered or spayed. HHPs may not be declawed.

**Benching:** Single cage size is approximate 22"x22"x22"; and is included with your entry. Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage. Cats for Sale Cages are only available with a paid entry. Cat litter will be provided; please bring your own litter box.

**Health:** It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, Calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. Claws for cats entered in competition must be clipped prior to benching. Declawed cats are not eligible for competition.

**Scoring:** All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with an Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

By entering, exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. CFA show rules may be obtained for \$7 each from CFA plus \$2 shipping, 260 E. Main St. Alliance, OH 44601.
