NEW Show Hall in 2023: TECO Expo Hall @ Strawberry Festival Fairgrounds 2301 W. OAK AVE PLANT CITY, FL 33563 Ph: 813-752-9194. The show hall is air-conditioned and is handicapped accessible. Parking (across the street) is FREE!!!

Entry & Payment Info: Entry fees include CFA surcharges. Per show rule 6.21 each entry must be accompanied by the stipulated entry fee. All entries must be paid in full within 10 days of receipt or prior to the start of the show, whichever is first. Make checks payable to That's My Point Cat Fanciers and mail to Kathryn Brady 864 Jasmine Creek Rd. Kissimmee, FL 34759. US bank checks only. Returned check is \$50 + all bank fees or send payments through Zelle to tmpcfca@gmail.com **LATE FEE: \$75 will be added to any payment not received by 10/28/24.** To expedite the check-in process we prefer exact cash. Check your confirmation for accuracy and contact the entry clerk with corrections BEFORE THE CLOSING DATE. No substitutions after the closing date. **NO REFUNDS AFTER YOUR ENTRY HAS BEEN CONFIRMED OR FOR FAILURE TO ATTEND THE SHOW.** By entering exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules. CFA show rules may be obtained for \$7 each from CFA, 260 E. Main St. Alliance, OH 44601.

Show Hours: Check in is 7:30 – 8:30 am, any cat not benched by 8:30 am will be marked absent and must check in with the clerk in each ring. Judging will start at 9 am. Advertised show hours are 9 am – 4 pm. All entries must remain in hall until closing time or until the end of finals.

Scoring: All entries in Championship (except Novice), Premiership (except Novice), registered Kittens, recorded Household Pets, and registered cats competing as Household Pets with a Household Pet color class prefix will be scored for CFA awards. Owners of cats/kittens without registration numbers can contact the entry clerk for a Temporary Registration Number.

Household Pets: All entries must be at least 4 months old; all entries 8 months or older must be neutered or spayed. Entries may not be declawed.

Benching: *No single space at End of Row. Exhibitors with a single entry using any size security cage are required to purchase an extra 1/2 cage. We will do our best to honor your benching requests. Cage size is approx. 22"x22"x22" and is included with your entry fees. Bring cage curtains (or coverings) to cover the sides, top and bottom of cage. Litter will be provided, but not litter pans.

Health: It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calicivirus and rabies. It is also strongly recommended that cats and kittens be tested and found negative for FeLV before entry. All claws of each entry must be clipped prior to benching. Failure to do so will subject the entry to disqualification. Declawed cats are not eligible for competition. No kittens under 4 months are permitted in the show hall.

Show Rules: By entering, exhibitors agree to abide by the decisions of the judges and the show committee and to adhere to CFA show rules.
